- 1. Call to Order by Commissioner Shafer at 1731.
- 2. Roll Call of Commissioners present Burrell, Clarkson, Shafer, Tuttle and VanDusen.
- 3. Pledge of Allegiance led by Commissioner Shafer.
- 4. Motion to approve minutes of CJFD Commissioner's meetings on November 4th, 2020 by Commissioner Burrell. Second by Commissioner Tuttle. Carried. None opposed.
- 5. Motion to receive and review the Treasurer's Report.
 - Explanation and discussion led by Treasurer. Motion to approve payment of monthly bills on CJFD's Expense Report for 12/2/2020 by Commissioner VanDusen. Second by Commissioner Tuttle. Carried. None opposed.
 - Discussion of year-end fund balances by Commissioner Shafer. Checking & ICS Shadow account fund balance of approximately \$197,000 noted and proposed transfer of funds to reserve accounts ensued.

 - Procurement of 2 new Pumper Tankers in 2021 to replace TA4 (Sta 34) and TA44 (Sta43) @ estimated cost of approximately \$775,000.
- 7. Motion to discuss 2020 CJFD Elections by Commissioner VanDusen. Second by Commissioner Clarkson. Carried. None opposed. Discussion occurred regarding times, notices, location and expectations.
- 8. Motion to review draft 2021 Meeting Schedule for CJFD Board of Fire Commissioners by Commissioner Clarkson. Second by Commissioner VanDusen. Carried. None opposed. Requesting to continue meetings on the first Wednesday of every month as currently established. Annual meeting and budget meetings potential dates discussed.
