- 2. Roll Call of Commissioners present: Commissioner Burrell, Clarkson, Shafer, Tuttle. Absent: Commissioner VanDusen.
- 3. Pledge of Allegiance led by Commissioner Shafer at 1839.
- 4. Motion to approve minutes of CJFD Commissioner's meeting on December 2nd, 2020 made by Commissioner Burrell. Second by Commissioner Tuttle. Carried. None opposed.
- Motion to discuss outcome of 2020 Corning Joint Fire District elections on 12/8/2020 by Commissioner Tuttle. Second by Commissioner Burrell. Carried. None opposed. Commissioner Shafer- 5-year term. Commissioner Burrell 4-year term. Commissioner Gridley 3-year term. Commissioner VanDusen 2-year term. Commissioner Clarkson 1 year term. Referendum carried.

Motion to approve the execution by Commissioner Shafer of a purchase agreement with MES in the amount of \$166,505.60 for acquisition of SCBA equipment under the NYS HIRE Contract# 69026 on 12/31/2020. Motion to allow procurement by Commissioner Burrell. Second by Commissioner Tuttle. Carried. None opposed.
 - Procurement of 2 new Pumper Tankers in 2021 to replace TA4 (Sta 34) and TA44 (Sta43) @ estimated cost of approximately \$775,000.

 to move forward in creating day room from Commissioners. Discussion occurred regarding volunteers
 doing work at the station and will insurance cover. Commissioner Shafer to follow up with Attorney
 Hannigan. To have further discussion on January 6, 2021 meeting.
 - Chief Branning discussed lockers at Station 16. States AMR is interested in the lockers. States that lockers are bulky and not needed. Motion made to donate lockers to AMR if AMR would like to accept them by Commissioner Clarkson. Second by Commissioner Tuttle. Carried. None opposed.
