- 1. Call to Order by Commissioner Shafer at 1732.
- 2. Roll Call of Commissioners present: Commissioner Clarkson, Commissioner Eccleston, Commissioner Gridley, Commissioner Shafer. Absent: Commissioner Burrell
- 3. Pledge of Allegiance led by Commissioner Shafer.
- 4. Motion to receive and review the Treasurer's Report by Commissioner Eccleston with a second by Commissioner Clarkson. All Commissioners in agreement with none opposed. The motion carried.
 - Motion by Commissioner Gridley to approve payment of monthly bills on CJFD's Expense Report for 12/07/2022 with a second by Commissioner Eccleston. All Commissioners in agreement with none opposed. The motion carried.
 - Motion by Commissioner Gridley to transfer \$25,000.00 from CJFD's ICS Acct# xxxxx4090 to CJFD's Checking Acct# xxxxx0297 to pay bills detailed in the monthly Expense Report with a second by Commissioner Eccleston. All Commissioners in agreement with none opposed. The motion carried.
 - Estimated Year-end Balances discussed. \$364,958 is the expected year-end balance and that includes approximately \$43,000 from equipment sales in 2022.
 - 2023 Tax rate discussed. Actual tax rate \$1.08 per thousand assessed value.
 - Motion by Commissioner Eccleston to Adopt Resolution 2022-12 accepting the NYS OCS Annual Financial Report (AFR) for 2022 in lieu of a Treasurer's Report with a second by Commissioner Clarkson. All Commissioners in agreement with none opposed. The motion carried.
 - Discussion ensued with EMS Coordinator Woodard about replacement of 2 AEDs. Performance features, cost and availability of AEDs from Philips, Zoll and PhysioControl were considered. Philips unit is priced according to the NYS HIRE contract and Zoll is priced in accordance with the NPP.gov contract. It was agreed that we need to acquire 2 units at this time. The FRX and Physio units are in stock but Zoll would be backordered for approximately 6 months. Chief Brenning expressed concern that whatever purchase we make, we should ensure that the model selected will be available in 1-2 years and not discontinued. Coordinator Woodard states there has not been feedback regarding this from distributors. Motion by Commissioner Eccleston to purchase 2 FRX AEDs with a second by Commissioner Clarkson. All Commissioners in agreement with none opposed. The motion carried.
- 5. Motion by Commissioner Gridley to approve minutes of CJFD Board of Fire Commissioner meeting on November 30th, 2022 with a second by Commissioner Clarkson. All Commissioners in agreement with none opposed. The motion carried.
- 6. Review of nominations for membership in the Fire Companies that comprise the firefighting force of the Corning Joint Fire District.

 Stations 16/34/43: One application is being reviewed by Chief Brenning and it will be discussed next month.
- 7. Motion by Commissioner Gridley to approve 2023 Meeting Schedule for CJFD Board of Fire Commissioners by Commissioner Gridley with a second by Commissioner Eccleston. All Commissioners in agreement with none opposed. The motion carried.

- 8. Motion by Commissioner Clarkson to discuss status of the following CJFD initiatives with a second by Commissioner Eccleston. All Commissioners in agreement with none opposed. The motion carried.
 - Paving project-Station 16. Commissioner Shafer would like to initiate quotes as the time to pave this will soon be here. Discussed options to call for quotes and pricing.
 - Transferring ownership of Stations 16 & 43 to CJFD- No progress at this time. Will continue to update.
 - Feasibility Study for replacing Station 34 discussed. Supervisor Feehan stated she will look at grants.
 - Motion to approve ECFD, Inc.'s use of Station 16 for a Comedy Night event on 2/4/2023. Comedy Night
 would be held on February 4, 2023. The meals would be provided by Corning Catering and distributed
 under his catering/liquor license. Motion by Commissioner Eccleston to approve request with a second
 by Commissioner Clarkson. All Commissioners in agreement with none opposed. The motion carried.
 - Proposed purchase of water softener for Station 16 discussed. Station 16 water comes from a well
 and is extremely hard. A test water softener was installed and used to wash trucks and improvement
 was noted. Quotes to provide soft water for the entire building have been obtained from Culligan and
 Chemung Soft Water. Discussion ensued about the merits of purchase or rental of a system. Motion
 by Commissioner Gridley to approve purchase not to exceed \$2,700 was seconded by Commissioner
 Eccleston. All Commissioners in agreement with none opposed. The motion carried.
- 9. Motion by Commissioner Eccleston to discuss firematic-related topics with District Chief and Deputy Chiefs was seconded by Commissioner Gridley. All Commissioners in agreement with none opposed. The motion carried.
 - Status of operations at Gibson Fire District: Chief Brenning reported that because of operational challenges at GFD, CJFD has agreed to provide first alarm coverage for all emergency response events dispatched by Steuben 911 in the area covered by the Gibson Fire District, effective immediately. It is anticipated that GFD Commissioners will move to close their doors on a permanent basis later this evening.
 - Community Service Program-Smoke Detectors: Update on status of Rotary grant program.
 - Storz hydrant adaptors for hydrants in the Village of South Corning. Mayor Thomas has notified us that 35 hydrants in the Village have Storz hydrant adaptors and 38 do not. 17 of the hydrants without Storz adaptors are new hydrants and 21 of them are older hydrants. The pricing for the adaptors is approximately \$210 each. Mayor Thomas requested to split the cost of these adaptors with a cap. Commissioner Shafer states the cost for CJFD would be approximately \$3,000-4,000. Commissioner Shafer to continue discussions with Mayor Thomas.
 - Chief Brenning requested budget for Installation dinner. \$5,000 has been allocated. Beth Cleveland and Derrike Kennedy have agreed to work on this. Installation dinner will be held on February 25, 2023 at American Legion.
 - It was noted during Truck Check events that batteries on Dewalt power tools have exceeded their lifetime. Per Chief Brenning, Milwaukee tools have a long-lasting battery and good performance reviews and MAC dealers such as ID Booth have higher quality tools than commercial stores. A Fuel Milwaukee drill, ½", ¼" impact, and Sawzall with a battery and charger is priced at \$1,200. Motion made by Commissioner Gridley to purchase 2 sets of tools for a maximum amount of \$2,500 was seconded by Commissioner Eccleston. All Commissioners in agreement with none opposed. The motion carried.
 - Discussion held regarding need for new hose. Chief Brenning to follow up on pricing.
- 10. Visitor's Comments: No visitors present.
- 11. Motion by Commissioner Eccleston to adjourn @ 1845pm. Seconded by Commissioner Clarkson. All in agreement with none opposed. The motion carried.
