



**Board of Fire Commissioners Meeting
Wednesday, August 5th, 2026
Station 16 East Corning Fire Dept, Inc.**

Minutes

1. Meeting was called to order at 5:32 p.m.
2. Roll call of Commissioners present was conducted. Commissioner Shafer, Commissioner Olmstead and Commissioner Gridley were present. Absent were Commissioner Smith and Commissioner Brenning.
3. Pledge of Allegiance was led by Chairman Shafer.
4. Motion made by Commissioner Olmstead and seconded by Commissioner Gridley to review and act on proposed minutes of the CJFD Fire Commissioners meetings on July 8th, 2026. All in favor. Motion carried.
5. Motion made by Commissioner Olmstead and seconded by Commissioner Gridley to approve the following nominations for membership in the Fire Companies that comprise the firefighting force of the Corning Joint Fire District. Coraline Vanskiver, Station 16 approved pending association's decision. All in favor. Motion carried. Josh Hand, Station 16 tabled after discussion.

 - Motion made by Commissioner Olmstead and seconded by Commissioner Gridley to approve renewal of CD#'s 3312,3313,3313 and 3315 on 8/31/26 for 6 months at 3.55%. All in favor. Motion carried.
 - Motion made by Commissioner Gridley and seconded by Commissioner Olmstead to approve transfer of \$85,000 from R4Apparatus Repair & Replacement Reserve Acct to a 6-month CD @ 3.55%. All in favor. Motion carried.
7. Motion made by Commissioner Gridley and seconded by Commissioner Olmstead to review current status of the following projects: All in favor. Motion carried.
 - Status Update: CGR Joint Efficiency Study with Forest View Fire District. Have not received it yet. Meeting scheduled for 9/3 to review.
 - Status Update: Consolidation of 3 fire companies. No real update
 - Renewal of Lease Agreement with Village of South Corning. Lease expires 12/31/2026. More information to follow.
8. Motion made by Commissioner Gridley and seconded by Commissioner Olmstead to discuss the following prospective purchases. All in favor. Motion carried.
 - Motion made by Commissioner Olmstead and seconded by Commissioner Gridley to make repairs to parking area at NCFD (2026). All in favor. Motion carried.
 - Replace overhead doors at Sta 16 (2027?) Chief Brenning will get estimates and report back.
 - Replace roof at Station 16 (?)
 - Motion made by Commissioner Olmstead and seconded by Commissioner Gridley to get a quote for tin for the exterior of Station 16. All in favor. Motion carried.
9. Motion to discuss firematic-related topics with District Chief and Deputy Chiefs.
 - 8 of our members signed up for the Philly Tin training to be held 8/22 and 8/23. Motion made by Commissioner Olmstead and seconded by Commissioner Gridley to offer to other area departments to attend at no cost to their department. Other departments must provide their own insurance for their members. All in favor. Motion carried.
